1. New guidance policy per VSBA.
 - a. “provides” as opposed to “approves” instruction; “is, does” as opposed to “shall be, may”
 - b. Includes a “community involvement team” which may be the Health Advisory Committee
2. Instruction not changing, but structure/documentation is
 - a. Combination of classroom teachers (lower grades), Health/PE, Counselors, Contractors
 - b. Gender separated as necessary
 - c. Office on Youth, RCASA
3. New FLE standards and new Health standards
 - a. Crosswalk previously provided by VDOE must be locally developed
 - b. Have met with PE/Health, Biology, Counselors; local crosswalk in progress
