Although the house looks like a group home, it is only designed and staffed for short-term stays. Clients are usually given 460 hours if they have appropriate waver. Clients without RSCB hours will be accepted on a sliding scale, with a cap of \$25.00 a day. She went to great detail to explain all aspects of the program for students with special needs that will be graduating.
