- The library requested from us that teachers notify them well in advance of projects so that they can order or pull supportive materials. Sometimes they need to set-aside resources for in-house use only if they anticipate high demand.

- Mrs. Indseth suggested that a line item the budget could potentially support replacing lost/damaged items to allow the library to have a more generous policy.


## Procedures and Compliance

- Members approved the change to include intervention placement. Parent notification of I/E for each quarter was also discussed. Schools were to get feedback from classroom teachers, and a plan will be finalized.
- Teachers had questions about moving students between reading and math intervention if they are identified Title 1 for only one of the subjects.
