- Topics for the year
  - o We have a group discussion about what topics committee members would like to have at the next meetings. We elected to wait until December meeting after the November 14 "Special Education Family Night" to decide topic based on responses.
  - o Several team members discussed and see a need for a parent resource center.
- What's new is Special Education for this school year
  - o 504 specialists still in place from last year.
  - o Applying for "Robots for Autism" grant that focus on social emotional development.
  - o We are implementing training with ECSE staff as Registered Behavior Technicians to work with students with autism in our schools. This program is a pilot that is hoped to be launched at other schools in later years.
- Parent Socials/ Children with disabilities gym time
  - o We discussed the idea of having a more social time so that families can connect with each other and school staff to build the community to then increase interest and membership with SEAC committee. We also talked about sports team opportunities for children with disabilities.
  - o Ann Bueche will make and send a mock flyer and survey for review by SEAC for a November 14 "Special Education Family Night". The plan is to send out mailed flyers for event.

  - o Playground is up and accessible as an ADA compliant space.

  - o Love Thy Neighbor is almost complete with their residential kitchen for our high school students to use.
