- Disagreements: What to do if you disagree with the school or IEP Team?
 - o 3 Options
 - Mediation (with VDOE Mediator)
 - Due Process (with VDOE)
 - Complaint Process (with VDOE)
 - Considerations
 - First, Look for resolutions at school
 - Second, Look for resolutions at central office
 - Finally, use the 3 options above
 - Questions to ask the school
 - What are my rights?
 - How can we settle this disagreement?
 - What is my next course of action if we do not come to an agreement?
- Early Childhood Special Education (ECSE)
 - For students starting at age 2 with disabilities
 - Transitioning planning for Kindergarten eligible students happens in spring
 - o ISP's are usually more focused on related services
 - Referred to as a Service Plan
 - IEP's are use special education services as well as related services
 - Student classroom or environment placements is determined individually

- Students are usually living in King George, but they may come to KGCS if parent works or student attends preschool in King George
- Questions to ask:
 - How often will my child have services?
 - Should my child have an ISP or IEP?
 - What school will my child attend?
 - What should I do if I'm not satisfied with the team decisions?
- Self-Determination
 - Promoting Self-Determination in your student
 - Students can become apart of the IEP Team and participate in processes
 - o https://imdetermined.org/ website is a good resource
- Accommodations and Modifications
 - Accommodations are when students utilizes resources to complete same objectives
 - Modifications are when students are working to a modified objective different from the class
- Placement Considerations
 - Least restrictive to Most Restrictive
 - General Education
 - Special Education Classrooms
 - Special Education Schools
 - Home Based
 - Hospital or similar environments
 - Your child will be working towards Standards of Learning regardless of placement
 - Placement considerations take place at each meeting
 - Questions to Ask
 - Is my child in the least restrive environment?
 - Is my child receiving access to general curriculum?
 - Is my child taking SOLS?
 - What accommodations will be listed in the IEP and how will be they be accessed by the my child?
 - Is my child accessing a modified curriculum and what diploma will my child be receiving?
 - Is my child tracking for a advanced diploma?
 - Is my child missing time in class for services? How does this impact my students education?
 - When will my child be back in their home based school?
